GREY LYNN NEIGHBOURHOOD LAW OFFICE  
**HELPING THE COMMUNITY  
IN LEGAL MATTERS**

The Grey Lynn Neighbourhood Law Office is a community legal service centre based at 449 Richmond Rd, Grey Lynn. Part of its current legal service is the availability of a law clinic at the Wesley Community Centre in Mt Roskill. This law clinic has been on trial since December 2004 on a fortnightly basis, largely to assist those in the immediate area (Mt Roskill) to access a lawyer. It has been found to be very useful to the community and on that basis the fortnightly service will continue until the end of May 2005. From June 2005 a lawyer will be available every week on a Friday.

Priority is given first for those in the Mt Roskill area and neighbouring Auckland City areas (council boundaries) and if you fall into low income in following communities: Women, Maori, Pasifika, Elderly, Refugees, Migrants; Unemployed, Beneficiaries

The lawyer will be available to give the following services: legal advice, assistance and if required representation within the following legal areas: Domestic Violence; Family (including custody and paternity); Immigration; Consumer (includes Debt issues such as hire purchase, repossession, bankruptcy); Tenancy; Minor Criminal and traffic. Do ask about other legal matters where it is not mentioned here.

The solicitor (lawyer) will not be able to help you with any commercial matters (e.g. purchase of property), wills or trusts. Where this is the case the solicitor can refer you to someone who can help you.

It is a donation-based service with a minimum donation of \$25.00 per consultation with the lawyer. If you are unable to afford this amount you can discuss this with the lawyer.

The law clinic is at the following address: Wesley Community Centre 740 Sandringham Rd, Owairaka. It is open from 9 to 4 pm with the last booking at 3.30pm. You will need to call the Grey Lynn Neighbourhood Law Office on 378 6085 to make an appointment, otherwise you can walk in and take your chance on the day.

We warmly invite you who live in the Mt Roskill area or around the Mt Roskill area to make use of this opportunity and look forward to seeing you.
