## TERMS AND CONDITIONS OF STALLION STATION PTY LTD 2007/2008 SEASON

1. This service contract is valid only between Stallion Station and the Owners of the mare(s) booked specifically by name.
2. The mare owner declares the named mare(s) shall be healthy and in sound breeding condition.
3. The stallion service fee will be payable within thirty (30) days of invoice date and the mare(s) owner agrees that the stud is under no obligation to offer a free return should the service fee not have been paid by the due date.
4. The stallion service fee will be invoiced following a confirmed manual positive pregnancy test, or following the due date of forty two (42) days if the mare is not resident on the stud and where the mare(s) owner or agent has not furnished the Stud with a negative pregnancy test.
5. For off farm breeds transportation costs & non-return of semen containers shall be debited to the account of the mare(s) owner.

### **6. Free Return Conditions:**

A free return will be offered to the mare(s) owner only under the following conditions:

- (a) Stallion service fee has been paid in full within thirty (30) days of invoice date.
  - (b) A negative pregnancy test certificate has been furnished to the stud.
  - (c) Failure of the mare(s) to produce a foal that stands and lives for seven (7) days.
  - (d) The mare(s) has been properly cared-for during gestation and presented for foaling under controlled foaling conditions.
  - (e) The mare(s) is not shipped overseas.
  - (f) Free Return claims must be notified to Stallion Station within fourteen (14) days of the mare's due foaling date or the birth of the foal.
7. Discounts as described below apply only to accounts paid within thirty (30) days of due date of invoice.
  8. Return service mares shall be liable for a \$330.00 administration fee.
  9. The Mare(s) Owner will be liable to pay interest of 18% per annum on all accounts not paid within thirty (30) days of invoice.
  10. All owners and agents of owners shall have joint and several liability for all amounts due under this agreement.
  11. This contract becomes null and void if either the nominated mare or the stallion dies.
  12. The breeder / the broodmare owner or person signing this contract shall provide the stud with any adverse details relevant to the mare's breeding history.
  13. The breeder hereby acknowledges that it is their responsibility to understand and agree to these terms and conditions of service - in particular the payment of service fee.
  14. Right of Refusal: The stallion management or the chosen stud has the right to decline any application for service or any mare at its sole discretion.
  15. If more the one delivery of semen is supplied per mare a \$50.00 fee will apply to cover additional freight cost, incurred by Stallion Station, this will be an additional cost to the owner.
  16. Any variation of the terms to this agreed between Stallion Station and the breeder must be signed off by management and confirmed by return mail or fax to the breeder or are not valid.

**By signing this contract the breeder certifies that they are the owner of the mare/s or have the authority to enter into this contract on behalf of the owner/s. They accept the terms and conditions above and take full responsibility for payment of the service fee and associated costs.**
